TERMS & CONDITIONS

1. The promoter is Tauranga Crossing, located at 2 Taurikura Drive, Tauriko 3110, Tauranga.
2. The Promotional Period commences Tuesday 2 June 2020 at 12.00am. The promotion ends Thursday 8 May 2020 at 11.59pm NZT.
3. To enter the Promotion, the entrant must nominate a registered club or team by filling in the entire entry form found at: <https://www.taurangacrossing.co.nz/news/local-legends/>. Applications must include a statement of less than 500 words explaining the reason for the application and why it deserves a grant. Applications can be supported by submitting photos or a video. Instructions on uploading these with the application are available and form part of the entry form.
4. Only registered clubs or team that reside in the Bay of Plenty, New Zealand are eligible to be nominated.
5. One entry (or nomination) per person is permitted. The entrant must be authorised by their club or team to make the application on its behalf.
6. False, misleading, or inappropriate entries will be disqualified.
7. There are four prizes which each consist of a \$5,000 grant:
 - a) The first grant will be awarded Tuesday 30 June 2020 from entries received 12.00am Tuesday 2 June – 11.59pm Monday 29 June NZT.
 - b) Second grant awarded Tuesday 15 September 2020 from entries received 12.00am Tuesday 30 June – 11.59pm Monday 14 September NZT.
 - c) Third grant awarded Tuesday 19 January 2021 from entries received 12.00am Tuesday 15 September 2020 – 11.59pm Monday 18 January 2021 NZT.
 - d) Fourth grant awarded Tuesday 23 March 2021 from entries received 12.00am Tuesday 19 January – 11.59pm Monday 22 March 2021 NZT.
8. The winner of the grant is the registered club or team that is nominated.
9. A panel of appointed judges will review all applications that are eligible for consideration for a grant. The judges will assess the merits of each entry and select one successful entry per timeframe indicated in term 7a, 7b, 7c, 7d.
10. The Promoter reserves the right to redraw the prize if the promoter is unable to contact a winner after four attempts by 5.00pm the following day using the contact details provided by the entrant.
